<ul> <li>DEPORTMENT</li> <li>A coach who is guilty of improper field decorum to the extent that his team is penalized for his action s or is ejected from the game by a game official must be reported to the Conference Athletic Director or President by his Booster Club within 48 hours for appropriate action.</li> <li>Game officials have the right to eject a player from the game for persistent unsportsmanlike conduct. Such ejection must be similarly reported.</li> <li>Booster Club officials are responsible for the deportment of their own supporters. Alcoholic beverages and profane or abusive language in or around the famous the shall be no smoking on the playing field or in the bench area.</li> <li>The Booster Club President is responsible for all actions of Booster Club personnel, participants, and their spectators both on and off this field.</li> </ul>	acility is not to	olerated

The season playing and practice schedule were adopted by the Booster Clubs. Team practice scheduling is a Club function within the limitations defined in the rule book:
Practices outside the TIFI approved calendar that is adoped by the conference are strictly forbidden and a violation of section 8.00

An official team practice starts & continues for that period of time when one or more team members & one or more coaches assemble anywhere for practice as definded in the rule b Coaches practicing outside the TIFI approved calendar or conference approved exceptions shall be penalized per the TIFI rule book.

All excessive winning margins of more than 40 points that could embarrass a team will be reviewed by the Conference Board per TIFI Rules All coaches are subject to background checks and must provide a valid state issued ID. All coaches applications are subject to approval of the TIFI Conference AD.
