- To ensure HLL is aligned with Little League International (LLI) District 35 guidance which recommends having a documented Covid-19 response plan
- To ensure HLL remains active (e.g., games, practices, fundraisers) in the event an entity requires such documentation; categories of those entities are but not limited to:
 - State/local public health organization (e.g., Sonoma County Department of Public Health)
 - o Other stakeholder groups to which HLL relies (e.g., Healdsburg Unified School District)

- 2. Follow new HUSD exposure/quarantine flowchart (see pictures below)





ENGLISH - Exposure Flowchart






