- Possible Switch of Banks

  Waivers are due by league playergent by 5/1/2021
- Boundary expansions will not happen during COVID
- Player ages and eligibility can make players who moved up but are still aged for miniors to move back down to minors or ect. This moves will be adjusted accordindly by the Player Agent and VP of Baseball
