## RENTAL PROCESS

- 1. At least two (2) weeks prior to the event, this completed Form, along with the appropriate Field Deposit Fee and the appropriate Field Fee, must be submitted to HCSSL's Tournament Director.
- 2. HCSSL's Tournament Director will verify that the requested field(s) are available and will notify you of their availability.
- 3. At least five (5) days prior to the event, the appropriate Team Fee, along with SSUSA team registration proof or Certificate of Insurance and Waiver of Liability forms for each team must be submitted to HCSSL's Tournament Director.

#### **MISCELLANEOUS**

- 1. HCSSL's responsibilities are limited to ensuring that the requested fields are in a safe and playable condition, lining the requested fields, and putting bases on the fields.
- 2. You are responsible for administering the event in a safe and prudent manor and providing for umpires, scorekeepers, softballs, etc.
- 3. Harris County does not allow alcoholic beverages in Bayland Park. It is your responsibility that this policy is followed during your event.
- 4. After the conclusion of the event, if the fields are left in a clean and playable condition, your Field Deposit will be returned to you.

### **EVENT CANCELLATION**

- 1. If you cancel your event prior to the day of the event, your fees, less the Field Deposit Fee will be returned to you.
- 2. If HCSSL, due to inclement weather, determines that the fields are not playable on the requested date, a mutually agreeable alternate date will be selected or your entire fee will be refunded.
- 3. If you, due to inclement weather, determine that the fields are not playable on the requested date, a mutually agreeable alternate date will be selected or your fee, less the Field Deposit Fee, will be refunded.
