Shane Morrison: All right, everyone. Welcome to the April board meeting.

Shane Morrison: with the roll call. Go ahead and start All right.

Stephanie Kline: Stephanie Klein.

Anna Mohamad: Anna Mohamad and Amjad Mohamad.

Alicia Swinney: Felicia Sweeney,...

Alicia Swinney: your coordinator.

Megan Clark: Megan

Anna Mohamad: There you are. Can you guys see that?

Stephanie Kline: Yes.

Anna Mohamad: So, our April agenda.

Anna Mohamad: Stephanie, if you want to start off with a recap of where we are with registration.

Stephanie Kline: Yeah. ...

Stephanie Kline: right now it looks like we have 113 registered. we've got 39 in the cart. there's actually a huge junior peewee team for cheer. There's 20 of them. So, I know at some point we move everyone around. but it's looking like 11U is at least solid for beginning numbers. 10U is at 14, flag is at 12. and then everyone else is still kind of low. anywhere between five and 10, but the cart has about 15 cheer and then there's maybe four to five for each one of the teams in it. So, that's what we've got so far.

Anna Mohamad: And I know yesterday we did have a really good turnout from the avocado festival.

Anna Mohamad: And they have through this month to sign up using the code as well.

Stephanie Kline: That's awesome.

Stephanie Kline: especially with us putting out when registration closes or at least pushing toward that we typically get more signups the month prior to it closing.

Stephanie Kline: And that's just what I saw last season.

Anna Mohamad: We're almost at double from...

Shane Morrison: Yeah, we need Yeah,...

Anna Mohamad: I think all in all, I'm pretty optimistic on all the teams being full. right now our biggest push is 13U and 12U

Stephanie Kline: Awesome.

Anna Mohamad: it turned out pretty good yesterday at the avocado festival for 13u and 12U too.

Shane Morrison: I'm going to be going on to base next Tuesday or Wednesday to Camp Pendleton to go put out flyers at the school and then the community center. So, as long as those don't get overtaken by Oceanside, then we'll be able to pick up some kids there.

Shane Morrison: We had a table going at the Don Dordan and I talked to three people that were actually from Mary Fay and I think the other one was the other one ...

Shane Morrison: They're All three of them were the pendant and they were actually looking where to register. and I gave them flyers and they were younger. but they were all new. They actually wanted to play last year, but for some reason they couldn't figure out a Pop Warner team. So, I'll be doing the base and getting flyers out there next week. So, hopefully we can pick some.

Anna Mohamad: Is there a way that we could reach out to all the Fbrook middle schools and elementary schools or whatever and have them send out a registration email or I've seen it in the past with Live Oak they advertise some sports in the Fast.

Megan Clark: I have the contact for they use peach jar or something it's called. I don't know because I don't get all this stuff...

Megan Clark: but I've sent over any flyers we have to that. I don't know if they actually send them out or not, but

Shane Morrison: Yeah, I don't think I've seen him.

Shane Morrison: I know Debbie is working with Live Oak. But in order to send out something, you got to go through another part of the school district, not the part that I deal with all the time because I only deal with facilities. and supposedly they're super strict and they don't put out those kind of flyers because then they got to put it out for everybody.

Shane Morrison: So, yeah.

Maurico Payne: You are correct.

Maurico Payne: That's happened with me and Bonsel. I got shot down. You remember how I told you I was trying to get it through. I tried to push it just as the secretary, then the principal. They pushed me to the district. I went in and met with the district secretary and also our new superintendent, and they said no just because it's an unfair advantage to other events or sporting events that had happened prior that didn't get their flyers put out. So, they told me no.

Alicia Swinney: cheer program. So that word has been going out to Mary Fay and also with Cameron's basketball team here on base.

Shane Morrison: I know we could put up a table for Live I know if you kind of keep it local and you got good relationships with the principal, they'll let you do it. but I don't know. It's kind of a stupid thing because it would be easy recruitment. But, I know doesn't Live Oak have a parent teacher conference whatever return day or whatever the hell coming up? Yeah.

Anna Mohamad: I think we've all been working on trying to get tables set up at open houses which I think are coming.

Anna Mohamad: I know we got permit in I think live oak I think Ally so that she could go to her

Shane Morrison: So I have totes that are set up.

Shane Morrison: I just would like at least a couple days notice so that way we can get you or even coaches too get those bins that has flyers and...

Shane Morrison: stuff like that that we can put out. So, I have not ordered yard signs.

Alicia Swinney: Shane, do we have any more yard signs?

Shane Morrison: I put out the five signs that we had left. I was actually going to talk about doing that. I know we have May I forgot I got a quote. I'll have to look for it again. but I basically created a yard sign based off the flyer that was made. I think it was \$250 for 11 or...

Anna Mohamad: I think we could get my open house signs. We did 10 and I think I was charged 150 bucks and she gets them to you in two days.

Shane Morrison: that's way better.

Michael Arellano: Hey I'm at 2%.

Michael Arellano: My phone's going to die. but if you guys need signs made I can try to get a quote from Sign Art. over at my company we use them a lot so I can see what kind of deal I can get.

Shane Morrison: Okay. Yeah.

Shane Morrison: Just get a quote and then send it our way and...

Michael Arellano: All right.

Shane Morrison: we'll compare between ideal.

Michael Arellano: I didn't know about the meeting.

Shane Morrison: Next time charge your phone full. I'll make sure you're put on all of our stuff.

Shane Morrison: I got to add you to all the demand list. Sorry about that.

Michael Arellano: All right,

Anna Mohamad: And then, our next up was just VP and cheer if there's any coach updates. I think at this point I know Alicia on the cheer side has sent out the certifications that we have up to this point. I believe you and Amjud have as well.

Anna Mohamad: So, I think we're just staying on top of that unless Amjud or Alicia, do you guys have anything you guys want to talk about specifically to cheer in football?

Alicia Swinney: No. just that myself and the other head coaches will be going to Vegas next month. So, be on the lookout for that. Bill, Shane, and Albert.

Anna Mohamad: Do you have anything immAmjad for football? No, just trying to push out the certifications to the all coaches. then we got our clinic coming up this month that we've got to prep for I don't want to do that to you,...

Shane Morrison: MJ's gotten the USA stuff all set up and all the head coaches have all the codes and stuff. so we should have those done already to be honest. But there's no excuse for

Stephanie Kline: Are those getting I didn't mean to interrupt I apologize. is there going to be a specific folder that you're saving those in? I know last year was kind of chaotic. They were coming from everywhere.

Anna Mohamad: Stephanie. I'll get it in a bulk.

Stephanie Kline: Thank you.

Anna Mohamad: Once they come to me, I'll put it in a folder and then I'll send it to you as a folder as of the whole organization across the board.

Stephanie Kline: And I'll, obviously save them online. they haven't done the purge on Affinity yet, so obviously I can't build anything on there, drop them into the buckets yet, but I'll get everything organized and that way it's just a super easy fill in. Awesome.

Anna Mohamad: Perfect. And then I could e also have Anna drop them in as I get them into the infinity.

Shane Morrison: Yeah, you can bulk pull them off of USA.

Shane Morrison: I found out this year from our reps. So, it's like two clicks and you can pull everybody's individually or as a whole their certifications.

Shane Morrison: So, that should be a lot easier this year.

Anna Mohamad: So we would be able to log in and...

Anna Mohamad: just get our organization, everybody that got a certification through them.

Shane Morrison: So if you log in you should have a man management window and then you should be able to see everybody that's registered and then you could see where everybody's at as far as completion wise and...

Shane Morrison: then once they it'll completed ified. and then it'll have their mandated reporter. It'll have their USA. you can even send them emails saying hurry up and do your s*** kind of deal. so yeah, there's a whole dashboard for.

Anna Mohamad: And I'm also and...

Anna Mohamad: then we're also waiting for the grant that we applied for. I haven't heard back from it.

Shane Morrison: Yeah, we didn't get any grants last year.

Shane Morrison: So, it comes I think the year the years the people that don't they have a better chance to get it the next year then every year if you keep applying for it you get a better and better chance kind of like the hunting lottery.

Anna Mohamad: And we applied for a sponsorship yesterday at the avocado festival.

Shane Morrison: So, Yeah,...

Anna Mohamad: I don't know if you guys heard, but the classic car people reached out to us across the vintage car club.

Shane Morrison: I applied for a spectrum, too. So, that can be anywhere for from a,000 to \$10,000. So, I don't know what they'll give me. the main goal is have a good report with the company,

Anna Mohamad: and then next up we have Danny. if you have any updates as far as uniform vendor or shirt. I know that that Josh's pricing was really good was blast.

Anna Mohamad: So if you have any updates for us,

Daniel and Wendy: Yeah. ...

Daniel and Wendy: I reached out to Tina again for the coach shirts. She's going to be the same as last year. So, it's going to be about \$20 per shirt and then obviously for the 2X will go up and the 3X will be additional. Ryan from Full Gorilla, the uniform prices are going to be the same as last year as well. the reversible jerseys, those are going to be 50 for football and then 51 for The pants though, he's saying they're \$50 a pair, and that's what we were charged last year. I found some other online vendor, this company called League Outfitters, where we can get white shut pants for about \$28 a pair that are padded already as well.

Daniel and Wendy: So, I'm going to reach out to him and see if I can get a written order based off of just some rough numbers because that will save us half from what Ryan at Full Gorilla was charging. Okay.

Shane Morrison: Yeah. And...

Shane Morrison: then make sure you check lead times with them. and then kind of research their credibility too. I know a lot of these companies that I mean we get if you look at our social media I think we get three a bubs a day of hey look at our product look at our product and...

Shane Morrison: there's so many people out there but I've heard other leagues what they go with this so cheap guy that looks like they have a good in Instagram profile and the order

Daniel and Wendy: The sh pants even on Amazon are like \$27 a pair.

Daniel and Wendy: You can literally order them. So that seems we could save money there. I don't know that there's going to be a better option for the board boards and coaches shirts because that's a killer price 20 bucks with the name and...

Daniel and Wendy: logo on the sides. And that just depends if we use same shirt. If we trying to use a different shirt, obviously the price is going to be different.

Shane Morrison: Yeah. Yeah.

Daniel and Wendy: Yeah, those shirts are 30 40 bucks just for the shirt.

Shane Morrison: But I think I'm just too spoiled with when it comes to the Under Armour and...

Shane Morrison: the Nike and yeah.

Albert Sandoval: Yeah, you got to double the price for those kind of shirts.

Albert Sandoval: And I can tell you now, it's not in the budget.

Shane Morrison: No, I need a fat boy shirt, dude.

Anna Mohamad: Danny,...

Anna Mohamad: I asked Shane today because I know for cheer we're doing uniform turnins. or if they're going to keep their uniform,...

Anna Mohamad: then obviously, we're using that. I was thinking is that if is it too crazy to give that option to the football players like Matthew two jersey?

Daniel and Wendy: We already kept all their pants.

Daniel and Wendy: Are you talking about for the jerseys?

Anna Mohamad: For their jerseys. because usually everyone keeps the same number for returning players obviously and returning players usually get first pick anyways. I don't know...

Anna Mohamad: if that would save cost or if parents would even do it but

Shane Morrison: I was thinking so there is a uniform standard,...

Daniel and Wendy: That would be just us giving them a credit.

Daniel and Wendy: I would assume a \$25 if they reuse because it's going to cost us 50 to buy a new one.

Anna Mohamad: Yeah, Yeah,...

Anna Mohamad: Okay.

Shane Morrison: So, we'll have to see.

Daniel and Wendy: The cost of the jersey so low we just buy new jerseys.

Daniel and Wendy: I don't even know if it's worth the hassle for 25 bucks.

Albert Sandoval: It's

Shane Morrison: hey, you have to pass the uniform inspection. So,

Daniel and Wendy: Okay. We can try.

Anna Mohamad: All right.

Daniel and Wendy: I think that's all that I got.

Anna Mohamad: And then I didn't put on here for cheer, but I think I got to look back, but I think it's like May 23rd for cheer fittings because our turnaround time is a little bit longer for that. And then Danny has it set up for June 8th for football. Ideally, we're going to try to just do one fitting and then we will have a secondary fitting, but we're not going to advertise that cuz we would like to get everyone fitted in that first day. So, more details to come on that.

Anna Mohamad: Discussed confidential information.....

Anna Mohamad: The only other thing that we just need to get on the calendar is we do need to set a day for our opening day because we are working on getting food trucks and vendors out to support that. So if we can figure out lock that in and then the only other date that was listed for our April and May is admin convention

Anna Mohamad: which I did send an invite to those who I sent that today. on the Westcon calendar, it only lists 5:31. it says 426 is to be determined on everything. So, that's why I sent out all May 31st information.

Shane Morrison: Okay. ...

Shane Morrison: So we start the 15th and...

Anna Mohamad: We could do the 28th.

Daniel and Wendy: Notes.

Anna Mohamad: It doesn't matter. I think when we had talked in the last meeting, we were going to do it right before game starts. So, we can kind of already know you're on what team and things like that. But if we want to push it sooner, then that's fine.

Daniel and Wendy: Are we July 13?

Shane Morrison: that will be the 5th or the 12th or...

Anna Mohamad: 15. Can we get Potter on a Saturday?

I have already taken care of Potter starting for football and As of right now, we do have cheer inside facilities, but I do not know yet if they're going to be charging us this year. they said last year that They kind of said it earlier this year. but then Vanessa has told me that they're taking forever and they don't know.

Shane Morrison: but they kind of gave me a hard date by the middle of June. if they haven't made a decision by then she believes it's going to be free. so we may be able to get those indoor facilities. So, we are facing a cost for indoor facilities. So, that's a discussion. Once we do know if there is going to be a cost, that's going to be me, Alicia, and Deborah Lee, the board basically we're going to discuss how we're going to be able to do that and how we're going to structuralize those practices. So, biggest thing is making it safe. we do need to purchase another mat this year, which we were supposed to purchase last year.

Shane Morrison: We do need to have that purchased this year for the cheer that it was approved last year to do so, but we just haven't bought it yet. but we need to be able to make sure that when it comes to them doing their tumblings, when it comes to them doing their arches and all your crazy stuff. I'm still new to cheer dad thing, so give me a break. we do need to make it safe for football players, yes, it is holes and stuff like that, but we need to figure out something that we can do for the cheer. So, I'm actively working on that to see what we can do if we do need to do majority of it outside practice. that also goes with him lighting.

Shane Morrison: So, I did pick up another light. I have so nices. I did get a light structure. So, we have a total of four. which I also believe that what's his name is going to be bringing his two back down for the bottom field. So, I think we're going to have a lot better lighting situation this year. I also talked to FPUD equipment rental and asked them to make available and they said they might be able to get us one more. and I told let me know if we have to rent one of the LED ones for a discounted rate. Let me know what it'd be. so we'll see. as far as Westcon, we didn't have a president's meeting this month.

Not maybe on their menu because their menu is kind of pricey.

Maurico Payne: But I told you, the other side of their business is where they prepare food for weddings and they distribute those types of foods throughout Southern California.

Maurico Payne: So, they make wedding type food so it's affordable and kind of cheap and kind of across the board to see if maybe they can give us a low pricing package and then we just tack on, x amount of dollars and have an event. But again, this is still in the works. I didn't really want to pitch it to you just yet, but that's what I was working on. and I think maybe we can generate a few thousand doing a murder mystery type dinner.
