**Financial, Call-up & Release of Information Policies**

**Financial Policy:**

Dues shall be assessed for each player to cover the cost of the yearly program not otherwise financed by Pine-Richland School District or by other means. All players/families are responsible for the total payments. As a Parent/Guardian of \_\_\_\_\_ I will be held responsible for making payments owed to the Pine Richland Ice Hockey Association (PRHA) for the 2017-2018 season. I understand that if payments are not made on the scheduled dates and if my child is not current with payments he/she will be ineligible for game and/or practice until his/her account is current. The payment terms are detailed in the **PRHA Policy Manual**.

**Call-Up Policy:**

Pine Richland Hockey Association (PRHA) will select one or two Junior Varsity hockey team(s) and one Varsity hockey team for the 2016-17 season from the 9-12th grade participants in the program depending on the number of participants. During the 2016-17 season the coaches may utilize players from a lower team to higher team (JV2 to JV1 or JV1 to Varsity) based upon need and injuries throughout the season. These players will have the opportunity to practice and/or play with the higher team. The call-up policy will be strictly at the discretion of the coaching staff.

A player that has the opportunity to play in **10 games** with the higher team would be assessed an additional fee equivalent to the difference between their assigned team and the higher team's fee (if, for example, Varsity fees were \$2000 and JV1 fees were \$1525, the player would be required to pay an additional \$475 after they participated in their 10<sup>th</sup> Varsity game). This policy is based upon the benefit of additional practices and games (by playing both JV-1 and Varsity).

I \_\_\_\_\_ acknowledge that with the acceptance of an offer by PRHA coaches to play 10 games or more on a higher team, I am responsible for payment of the difference in fees between my assigned team and the higher team fees for the current season.
