





Risk Management / Background Check Submission

Concussion Management Course

All WVSA members that are required to undergo background checks must complete an online Concussion Management Course offered free by US Youth Soccer/CDC or NFHS and will be required to upload a copy of your Certificate showing that you have completed the course during the Risk Management Registration. To complete the course and receive your certificate go to: <u>HEADS UP to Youth Sports | HEADS UP | CDC Injury Center</u> or <u>NFHS Learn | Interscholastic Education,</u> <u>Made Easy</u>, you will need create an account for whichever one you choose.

Once complete, upload it to your registration. If you have an old certificate on file, click on it and in the upper right-hand corner there is a delete button to delete the old one so you can upload the new!

West Virginia Soccer Abuse Prevention Training for Adults (SafeSport)

West Virginia Soccer is aware of several program options for awareness/prevention training of sexual abuse. West Virginia Soccer supports the SafeSport Act by requiring all persons identified under this policy to take the program provided by the U.S. Center for SafeSport.

1. Visit SafeSport using the Sports Connect specific URL shared above, Click Login from the upper right of the screen.

2. Choose Forgot Password and enter your email address or your SafeSport username and then click Reset Password.

3. If your email address is on file, you will receive an email with a link to reset your password and access your account.

New Users – You are new to SafeSport training

- 1. Visit SafeSport using the Sports Connect specific URL, shared above. This URL instantly tags the user with "Stack" and allows us to receive the user's course results.
- 2. Use the Sign-up form to create a new account.
- 3. New Users need to do the 90-minute SafeSport Trained Core

Refresher Course(s) for Adults

In addition to the initial training, a refresher course is required on an annual basis effective the calendar year following the completion of the initial training, you will use the same log in and pw that you used above to complete these courses.

Annual Refresher West Virginia Soccer Abuse Prevention Training for Adults

West Virginia Soccer currently requires all Adults who are required to take the initial U.S. Center for SafeSport course to take the U.S. Center for SafeSport's official refresher course. Refresher course is required on an annual basis to be completed by December 31 of the year following the year the initial course and subsequent refresher course was taken. Set aside up to 30 minutes to take the refresher course.



Example: If an Adult takes their initial course during 2019, they must complete their annual refresher no later than December 31, 2020. They may take the refresher anytime between January 1 and December 31 of 2020, no need to wait till a year expires

This is important as West Virginia Soccer requires all risk management credential requirements to not expire during the soccer year (September to August). Adults will be able to take their annual refresher courses anytime to be ready to receive their credentials, assuming all other requirements are met, by the end of August.
