You represent GARY STEELERS Pop Warner. You represent everybody that came before you, and everyone that will come after you."

We are looking forward to you and your child(ren) being part of our family. Our program has been around since 1995 and has had incredible success from various football and cheer teams participating in the Pop Warner National Championship Super Bowl in Walt Disney World, Florida and several participants have been recognized on the local, regional and national level for outstanding academic achievements. For 2019, we have planned another fun and exciting season for our participants. We are confident that this will prove to be a positive and rewarding experience for your family.

The GARY STEELERS in concert with Pop Warner Little Scholars, Inc. is designed to teach the fundamentals of football and cheerleading, and is open to all boys and girls who meet age, weight (football), scholastic and health requirements. We not only strive to teach the fundamentals of these two sports but also to demonstrate to our participants the ideas of sportsmanship and fun. NO TRYOUTS; NO CUTTING; AND MANDATORY PLAY FOR ALL PARTICIPANTS.

The GARY STEELERS organization stresses safety in all areas of football and cheerleading. We have excellent equipment, which is certifiable and is comparable to the High School and Collegiate programs. All volunteers submit to a background check and ALL coaches and team moms are certified through USA Football and other trainings.

We are dedicated to developing GARY STELLERS Pop Warner into the level of program we know it can be – you will notice considerable improvements to the GSPW program in the coming years! We're very excited about the things to come! Our goal is to provide your children with the best experience possible, both on and off the field, this is a team effort and we NEED PARENTAL SUPPORT – YOU play a vital role in the success of not only a season, but the entire organization year after year. We are an organization of volunteers and we need your support and participation.

#### **Gary Steelers Pop Warner Policies & Procedures**

Due to the fact that GARY STEELERS Pop Warner (SGPW) is part of a National Organization, we must adhere to strict regulations within our own local association in order for the program to run successfully. We require parents to cooperate with our policies and procedures. Please carefully review the following policies.

**Paperwork Policy** – All paperwork is due by August 1st. If all paperwork has not been submitted the participant may not be issued equipment. If failure to submit paperwork continues after August 1<sup>st</sup> the participant may not be allowed to participate in GSPW in any capacity during the 2020 season.

**Payment Policy** – All registration and fundraising fees must be satisfied before a player or cheerleader will be registered for the season. No participant will be allowed to partake in <u>any</u> organized practice unless <u>all</u> registration requirements have been met.

**Fundraising Policy** – We are a not-for-profit organization and our revenues are devoted to the safety, support and recognition of the GSPW participants. Uniforms, lights, safety equipment, referees for games, awards, cheerleading competition fees, insurance and security are just some of the many expenses our organization incurs. The total cost to put each player and cheerleader on the field far exceeds registration fees paid at sign-up. GSPW relies on your support through fundraisers to make up the difference.

**Refund Policy** – A \$25 administration fee will be deducted prior to August 1<sup>st</sup>. No refunds will be offered after Aug 1<sup>st</sup>. If GSPW does not fill a team you will receive a full refund.

**Parent Participation Policy** – GSPW is run 100% by volunteers. Due to the fact that there are many more jobs to be done than hands available to do them, we require the participation of parents throughout the season. You may be asked to assist with some of the tasks required to run the program.

**Certification/Weigh-In Policy** – GSPW requires that all participants, including coaching staff, attend the NWIPLS Mandatory Certification/Weigh-In, which is scheduled for August 22nd at Porter County fairgrounds. Any participant that misses the August 22nd date <u>will not</u> be allowed to participate in the first game of the season and WILL be charged a late certification/weigh-in fee. The participant will then have to attend the alternate certification/weigh-in, which is scheduled for August 29<sup>th</sup> at Hobart PW.

Image Release – Photographs, images, and/or video taken of my child may be used for promotional materials that include, but are not limited to, brochures, newsletters, newspaper articles, websites, etc. and may be used without prior notification.

**Social Media** – Any adult who criticizes, bad mouths, attacks, etc. an official, coach, volunteer, staff member or participant on any social media site including, but not limited to, Facebook, Twitter, Tumblr and personal blogs, will be banned from any and all Pop Warner activities one (1) year from the date of the offense. Their child(ren) may be banned from any and all Pop Warner activities for the same period of time as well.

**Football Equipment Hand Out/Turn In** – Please see attached equipment rental agreement. Must be signed and turned in during equipment handout. (Scheduled for the week of July 22<sup>nd</sup>)

**Field Use/Access** – Access to the practice/game field is limited to certified and badged Pop Warner players, coaching staff, referees, officials and volunteers.

**Turf Field Rules** – There will be no food of any kinds on any turf field. Water is the only beverage allowed. Gum chewing is not allowed. Metal spikes or high-heeled shoes are not permitted. No chairs of any kind are allowed. Carts, canopies, umbrellas or any spiked object is strictly prohibited.
