Approval of previous meeting minutes ~ Val McKee

- Val McKee sent out the January meeting minutes, Nicole Richko motioned to approve minutes, Amanda Keenan second the motion. The minutes were approved.

Treasurer's Report ~ Jill McCormack

- As of 1/30/20 we had a balance of \$10,167.00.
- Jill shared a summary of receipts and disbursements for the month of January.

Cheer Update ~ Amy Worley

- Amy and Amanda reported that all cheer coaches will be taking the concussion training online through Centers for Disease Control. This training is completely free of charge. We discussed looking into it to make sure it covers all that we would need or benefit from it or if it would be more beneficial to pay for a training that will cover all we may experience.
- They will not doing Cheer University training because they believe they have gotten all they can from it and it will not be beneficial or cost effective.
- Amy is having trouble finding a good price for the uniform they typically received from our vendor for the same price. They are looking into other options at this time.
- Sydney Boras agreed to coach Super Cheer and Ashley Nolan agreed to coach Little Steps.

Football Update ~ Al Crema/Anthony DePaola

- The Metro league has two teams who are going to their meeting to discuss joining the league. Summit has left the Metro league so if they do not get either of the other two teams to join, our fees may increase.
- Weight limits went up ten pounds per level. Junior level, children must not be more than 155lbs. to run the ball. Those over that weight will have a mark on their helmet so referees know they cannot play a skilled position.
- We discussed equipment checks and possibly coming up with another system. Jessica and Jill will cash the equipment checks that are left.
