Secretary's Report:

1. Approval of January 11, 2016 Minutes.

Shelly made a motion to approve the January 11th minutes. Chris 2nd. Motion passed.

Old Business:

- 1. Field's For Kids Usage meeting with CRUSA
 - a. Update from meeting: Jonella Rodemacher and Cindy Hood met with Janice, Shelly, Chris, Kristen, Deb, and Mike on January 21st to discuss the terms of a partnership with CRUSA Fields for Kids. The terms they discussed were:
 - i. \$3500 flat fee that could be made in 3 payments.
 - ii. The Lightning could use a lit field if necessary for \$150/game.
 - iii. The agreed upon fields will most likely be 1 and 12 with the intention to switch the orientation of field 12.
 - iv. We must pick up our trash after use or will be fined \$100.
 - v. The charge to paint both fields would be \$70/time with the goal to paint about once a week.
 - vi. Usage fee to increase annually, amount TBD based on 1st year outcome.
 - b. Proposal discussion: Shelly shared that Jonella was invested in "making this partnership work." Janice pointed out the benefits: central location, restrooms, good parking access, increased exposure since our name and logo would be added to the sign. One of the drawbacks is that sometimes, due to weather conditions, the fields will be closed and therefore we would be

unable to play. There is the potential of being able to become a 501C in association with CRUSA in the future. The cost to do this would probably be \$1000-2000; however, our donations could then be claimed as tax deductions.

c. Alternate arrangements for when CRUSA fields not available

- i. May 21st definitely need to relocate-Mike will look into booking this game elsewhere (Holmen HS or Onalaska field?). Also need to discuss with Jonella the logistics of moving the goals for this game since we are unable to drive on the fields. Chris made a suggestion to buy wheels for the goals.
 - ii. May want to Consider April 7th or May 6th.

Sarah made a motion to accept the Fields for Kids proposal with the option to review the contract when available. Shelly 2nd. Motion passed at 6:47 p.m.

2. Registration Fees

- a. Fees for HS and Youth-\$200 for a returning player and \$150 for a Youth or new HS player.
- b. Discussion: Shelly felt that if we increased fees, it could scare new people that were potentially interested in joining. Sarah was interested in keeping fees the same since we do not have a strong coaching presence for the youth teams at this time.

Deb made a motion to keep 2016 fees the same as 2015. Shelly 2nd. Motion passed.

3. Player recruitment

- a. Flyers made and sent to club members via email for recruitment help.
- b. Ad developed for Park and Rec departments: La Crosse's flier was already printed for spring. We may get into Holmen's booklet if all the ad space doesn't fill. Onalaska was not contacted.
- c. Lightning night at the Chill Feb 19, 2016. Tickets for Lightning Lacrosse players would be free. Parents would have to pay. Some sort of shot activity during the intermission between the1st and 2nd periods is being worked on.
- d. Mike will email the schools and see if we can set up a table during lunch the week before registration. We will staff that table

A motion to approve the budget with the changes was made by Deb. 2^{nd} by Sarah. Motion passed at 8:11 p.m.
