#### **Coaching Director Report:**

Chris is in the process of restringing heads at this time.

Chris stated the Omni Center is very limited on dates – 2 practices for the first 3 weeks of the season – Chris checked into the Wellness Center on availability and cost – average cost is \$63.33 per hour – which is down from \$100 and with every 10 hours booked, you get 1 hour free. Chris will follow up with Dick's on sponsorship within the next 2 weeks.
