Several sets of Rules apply to the operations of Little League, to include but not limited to:

- a) The Official Little League Playing Rules: a colored booklet available for each playing division and supplied to each manager and housed in the League Concession Stand for reference.
- b) The Official Little League Rules and Regulations found in the Mobile App: Little League Rulebook.
- c) The Constitution of Coronado Little League: filed and approved by Little League Southwest Region on January 21, 2025. A copy is posted on the League Website for reference if you desire to examine it.
- d) The Operating Bylaws for Coronado Little League: are set by the Board of Directors on an annual basis and are held on file by New Mexico District 8 as well as housed in the Little League Concession Stand for reference. The Board of Directors, at its discretion, may, by majority vote, change any Operating Bylaw, at any board meeting which quorum is present. Managers will be informed by their player agent when any Operating Bylaw is changed during the course of the season.

Several sets of Rules apply to the operation of the League as set forth with and by the Town of Bernalillo as terms of the facility use agreement, to include, but not limited to:

- a) The league baseball and softball fields shall not be used for parties. The Town of Bernalillo rents out the parks and pavilion for private parties for a fee and a damage deposit. Pizza and drinks after the game, on the field is permitted. However, a separate day/event may not take place on the little league grounds.
- b) No vehicles are allowed beyond the designated parking areas, except for delivery purposes and that any delivery vehicle is returned to the designated parking areas as soon as delivery is completed.
- c) The League is not authorized to permit the use of fields to another league, organization, school district, civic club, individual, etc, without prior written consent of the Town. This includes any camps, scrimmages, tryouts and/or tournaments.
- d) No boisterous conduct or loud music, to include walk-up music. After proper warning, should conduct of the activity continue, individuals and/or the entire group may be required to vacate the park facility prior to the scheduled conclusion of the activity.

## **BYLAW I – SPORTSMANSHIP**

The early experience in younger players determines a child's decision to continue playing in the older divisions. Managers and coaches most influence these experiences by the atmosphere they create for their team and by the way in which they relate to the players individually. A spirit of competition is desirable, but winning should not be emphasized at the expense of the growth of a player. Please keep in mind that Little League is for the kids, not for the managers, coaches or parents. Its purpose is to build character, not to win ball games.

# BYLAW II – ALCOHOL & TOBACCO

Little League Rules is clear about such conduct. Alcoholic beverages are not allowed in the Coronado Little League Complex, and any use of such before or during games or practices or any Little League gathering and/or event is strictly forbidden. Use of any form of tobacco or cannabis products, including e-cigs/ vapors, and chewing tobacco, during any Little League gathering and/or event is also prohibited.

# **BYLAW III – CONDUCT**

Abusive conduct or language by anyone, towards anyone is absolutely prohibited and will not be tolerated by Coronado Little League. Profanity by anyone is not allowed and is cause for ejection from the complex, after one (1) verbal warning, including players, managers, coaches, umpires and spectators. Fervid disagreement with Umpires' decisions by players, managers, coaches and spectators is also cause for ejection without warning. Judgement calls by Umpires, including parent volunteer umpires and Jr. umpires, are not subject to dispute or comment at all by anyone at any time.

Players, managers, coaches and spectators may not direct comments in any form to players and coaches of opposing teams nor do anything to distract them. Players, managers and coaches may not direct comments toward spectators. No one except managers and coaches may comment to players in a way that could be construed as coaching or directing play at games. Please only cheer and encourage players. Do not yell, discourage, criticize or "coach" players, managers, coaches or umpires.

# **BYLAW IV- RULE INFRACTIONS & DISIPLINE**

Infraction of Little League Rules, including Local Rules, is grounds for immediate removal from the game and the Coronado Little League Complex by the Plate Umpire or by the Board member on duty, at their discretion. Ejected individuals must be "out of sight and sound" of any games at the Complex. Ejection from a game or from the Complex requires that the Umpire or Board member on duty submit a written report of such action to the President, Vice President within (24) twenty-four hours. That report and reports from other participating parties will be the basis for possible further disciplinary action by the Board of Directors under rules specified in the Constitution, although the President or the Board of Directors may request testimony from other later.

Disciplinary action could include a letter of reprimand, a one game suspension, a multiple game suspension, or suspension for the remainder of the current season. Disciplinary action against any League Member requires: (a) that Member to be informed in writing of the charges; (b) that Member to be given an opportunity to defend oneself in person before the Board of Directors (c) that Player Members be accompanied by their manager (and parent if desired); (d) that any discipline be approved by (<sup>2/3</sup>) two-thirds of a quorum of the Board of Directors.

The President (or Vice President in the President's absence) may, however, suspend any Manager, Coach, Player, or Member from duties and/or from presence at any Little League activities until the next Board of Directors meeting, and may suspend any Umpire at any time. The Field Monitor may eject anyone for violation of any rule or to maintain public order. The Board of Directors has approved the appointment of a Disciplinary Committee to expedite review and response to events potentially requiring discipline. Such committee shall consist of the President, Vice President, Safety Officer, and the Director of the Division involved in the event. A quorum for this committee is (4) four members. Meetings of this committee are for the sole purpose of reviewing events and actions of participants in Coronado Little League and for determining additional appropriate discipline, if any. Repeated infractions increase the risk for the offender's player to be disqualified from Allstar Tournament Selection. Meetings may be called by the President within (48) forty-eight hours. Members of Coronado Little League may never appeal the decision of this committee to the Board except for claims of violation of due process.

# **BYLAW V – CONTACT LIMIT**

A maximum of (4) four team contacts (minors and above), and a maximum of (3) three team contacts (slugger - player pitch and tee-ball) including practices and games, are allowed in any given calendar week, with the exception given to All-Star teams who have no maximum limit. This limit includes batting practice, although cage practice and field practice occurring on the same day at back-to back times are to be considered (1) complete practice and not separate.

# **BYLAW VI – HEADWEAR**

Uniform hats are part of the uniform and must be worn properly, with bill facing forward, whenever on the field, during a game, unless a player is wearing a helmet. Helmets must be worn during a game anytime when out of the dugout while team is on offense. During practices, anytime players have a bat in hand, all players nearby must wear a helmet. Managers and coaches who choose to wear hats/visors at game time may do so only if it is worn properly, with bill facing forward.

# **BYLAW VII – SCOREKEEPERS**

The Home team in all divisions of Sluggers and above must provide an Official Scorekeeper, who is a backup resource to the Umpires for tracking outs, balls and strikes. This person is the only Official responsible for tracking runs and keeping the pitch counts. After each game, the Scorekeeper has the game Umpire sign the Official scorebook, which is obtained from the Little League Concession Stand and returned there after the game. Each team should keep its own team scorebook separately from the Official Scorebook.

## **BYLAW VIII – UMPIRES**

The Home team in all divisions of Sluggers and above will provide a plate Umpire and the Visiting team will provide the Field Umpire. Umpires should report  $(\frac{1}{2})$  half an hour before the official start of games. Disrespectful behavior in any manner to the umpires will not be tolerated and will lead to removal from the game and complex.

# BYLAW IX - CONCESSION STAND

The Board of Directors will run and maintain the Concession Stand. A Concession Monitor will be in charge of running the Concession Stand and will determine the number of individuals needed for the day to run the Stand. The Monitor will be authorized to prohibit any individuals deemed unnecessary in the Concession Stand for that day, without question. The Concession Monitor will log a start and end dollar amount and log an inventory list daily. Only Concession Monitors will be permitted to handle cash during Concession Operations. No individual under the age of 12 will be permitted to assist in the concession. No individual under the age of 16 will be permitted to handle money and/or credit card transactions.

## **BYLAW X – FIELD PREPARATION**

The Home team must prepare the field before each game, including raking, watering, chalking and setting up the bases. Home team should report to the field for set up  $(\frac{1}{2})$  half an hour before the official start of games. The Visiting team must repair the field after each game, including and locking up bases and tools. If Coronado is hosting an Inter-League Team, the Coronado Team is responsible for field prep and repair.

## BYLAW XI – TRASH

Trash on and off the field must be completely cleaned up after each game. Spectators are responsible for picking up trash on their respective sides. Managers for each team are responsible for cleaning up each dugout. Failure to pick up trash in dugouts by managers and in the stands by spectators may result in the forfeit of the next scheduled game, at the discretion of the Board of Directors.

## **BYLAW XII – PRE-GAME MEETING & INSUFFICIENT PLAYERS**

A pre-game meeting between managers and umpires must be held (5) five minutes before each game, and once it begins, the Plate umpire is in complete charge of the game and field, although umpires are in charge of safety upon their arrival to the field. Managers must give the Plate Umpire an official copy of their lineup with both first and last names, including substitutions that are present. Managers must also give a copy of their lineup to the opposing manager and the Official Scorekeeper. In all cases, the Umpire's lineup copy is official.

If a game is not played because of insufficient players [(9) nine are required to begin and continue any game in the Slugger Division and above], the game is forfeited by the team having too few players. In such situations, the players may practice together or separately under the direction of each respective coach, but not using the scheduled umpire. If both teams have too few players, the game is registered as a tie in the standings. Such games will not be made up. Providing temporary replacement player (i.e.: from Minors) is not allowed. Managers whose rosters drop below 12 players must notify their Division Player Agent immediately. In such cases, the procedures for calling up a permanent replacement, from the Rule Book, from the division, or from a waiting list, will be applied. Managers may not contact replacement players until the Division Player Agent has placed the player on the team.

#### **BYLAW XIII – FIELD CONDITION**

Beginning with the pre-game meeting, the Plate Umpire determines the acceptability of the playing field and the weather. No sooner than three (3) hours before the game has commenced, the Board Member on duty may declare one or all fields unplayable and the Board Member on duty may at any time declare weather conditions to warrant a suspension of games. If lightening is detected consistently within 8 miles by the use of the League specific lightening app, games must be suspended and all people cleared from the complex as soon as possible. Upon a reasonable wait time, as disclosed in the Safety Plan, games may be restarted at the discretion of the Board Member on duty.

#### **BYLAW XIV- DARKNESS**

All games must be stopped precisely at sunset, by decree of the Board Member on duty. In any case for any division, the Plate Umpire can declare playing conditions too dark or unsafe to continue at any time, and as such has the authority to immediately stop the game.

#### **BYLAW XV-PROTESTS**

Protests will be considered only based upon violation of a rule or use of an ineligible player or pitcher. Judgment calls are not subject to protest. Know how to handle a protest (See Rule 4.19). Managers and coaching staff must download the LL Rulebook from the respective AppStore. The League will provide a \$2 refund for the purchase of the App should managers and coaching staff request reimbursement It is better to delay a game to correct a misapplied rule than to protest. An opposing manager, coach, scorekeeper, umpire or spectator who knows the other team is about to use an ineligible player or pitcher must notify the umpire before the player is used.

#### **BYLAW XVI- POSTPONED GAMES**

If a game is postponed due to weather, field conditions, or otherwise, it will be rescheduled for the next available Saturday at 3:00pm, as agreed to by the Board of Directors, regardless of the advantage or disadvantage of either team. Although umpires may suspend a game for a variety of reasons, games may be forfeited only by the majority vote of a Board of Directors. Managers may not reschedule games for any reason. The division director will work with all coaches involved to confirm rescheduled games. If you have a concern about being able to play a scheduled game, consult your Division Director immediately.

## **BYLAW XVII- RUN LIMITS**

Run limits are specific to each Division within the League and are provided in more detail on pages 6-9.

## **BYLAW XVIII - SAFETY**

Safety always comes before all other concerns. Safety is everyone's responsibility, although League Officials, Managers, Coaches, and Umpires should show greater responsibility than others. Anyone, including spectators and players, should call to the attention of the appropriate person any obvious safety concern. Managers and coaches must be receptive to anyone calling their attention to a safety issue, and they must ask their players and the parents of their players to be constantly attentive to safety issues. For example, during games players may not hold bats unless they are outside the dugout with a helmet on and preparing to take their place at the plate. All offensive players outside the dugout must wear a helmet at all times. Between innings, multiple players may not warm up simultaneously with bats. During practices or during pre-game warm-ups, if bat drills are used, a Coach must supervise this activity directly by maintaining close visual contact with all players involved and with anyone who may come close to players using bats.

Only Junior and Senior Divisions may use on-deck circles for the next batter to warm up. Traditional batting donuts may not be used in any Little League Division, and no batting donuts or weights may be used in Majors or below. Batboys and Batgirls must be rostered players from the participating Team and must wear helmets at all times. No offensive player in any division may take off a helmet before entering the dugout. After one team warning by the Umpire, further violations subject the player, coach or manager to ejection from the game at the discretion of the umpire.

No siblings, sons, daughters or friends are allowed in the dugout at any time. Non-player individuals in the dugout, assisting the coaching staff must be at least 16 years of age with a background check on file with the league.

At the Manager's discretion, he/she may have two adult base Coaches. However, no Manager shall leave the dugout unsupervised by an adult. A registered assistant Coach must be identified to supervise the dugout. If a manager does not have more than two official Coaches or an officially registered assistant Coach, then he/she should have only one adult baseline Coach and one Player baseline coach.

# BYLAW XX - SPRING SEASON DRAFT

Parent request for managers (not assistants/coaches) will be acknowledged this season but not guaranteed placement. Coronado Little League Board of Directors guarantees that all players registered by draft day will be placed on a Spring Season team. We do not make any manager placement guarantees. The only players guaranteed to a team are those who are children to the approved manager and coaches of the team with completed background checks and training certificates prior to team draft. Each team will not exceed one (1) manager and two (2) coaches. Siblings, not immediate family, in the same division wishing to be placed on the same team may request so via email after the players have been registered, at playballcoronado@gmail.com.

There will not be a draft in the TBall division. A committee consisting of the President, Vice President and Division Director will place registered players on teams accordingly.

Slugger division and above, in baseball and softball, with 4 (four) or less teams, will participate in a draft, with <u>all</u> players in the respective division entering the draft, regardless of who the player played for in the prior season.

Slugger division and above, in baseball and softball, with 5 (five) or more teams, returning division managers will have the option to draft all of their players or, keep their returning players that have indicated a request.

Any players moving up to the next Division will be placed in the draft regardless if their manager from the previous Spring is moving up Divisions.

Trades will not be allowed once a draft is completed.

## BYLAW XXI – FALL SEASON DRAFT

The League will open Fall registration on May 19, 2025. Registration will close July 19, 2025. There will not be a draft of players for Fall Season and coaches request will not be honored due to the small pool of players in the Fall Season. All players registered will be placed on a team by the President, Vice President and respective Division Directors. Fall Season will only be for players entering the Minor Division and above for the following Spring season.

# BYLAW XXII - ALL-STAR TOURNAMENT DRAFT

#### Minors, 9/11, Majors - Baseball or Softball Divisions

Players league-age 8-to-13 to be selected to tournament teams in the Minors, 9/11, Majors - Baseball or Softball Divisions must have amateur status, and have participated as an eligible player in eight (8) regular-season games by the beginning of the Tournament, except for the school baseball or softball season. Players qualifying under the school exception must participate in 60% of the games available to them. Players may be selected to an age-appropriate team without respect to division of play during the regular season.

#### Senior League Baseball or Softball

Players league ages 12-to-16 to be selected to the Senior League Baseball or Softball Tournament Team must have amateur status, who has/is registered with a local league in which they meet the residency or school enrollment requirements by the final day of league registration.

#### School Baseball or Softball Program Participation

A player who is NOT able to participate in a number of local league regular season games because of participation in a school baseball or softball program will receive an adjustment on the minimum participation in games required under this rule, provided the player was a registered member of the league by the final day of league registration within that division. Players who qualify under this condition must play sixty (60) percent of the games available to them.

#### **Injured Players During Regular Season**

The local league Board of Directors may permit a player to be eligible for selection, who does not meet the games-played requirement, if the player provides a physician's note documenting an injury or illness prior to, or during, the current season prohibiting his/her participation; and such note releases the player for the balance of the Regular Season and/or Tournament Play.

Player selection in every division will be based on three (3) important criteria requirements: Eligibility, Player & Parent Conduct and Commitment.

**Eligibility:** As stated above, a player will have had to play their required number of scheduled games, in their entirety in the Division in which to be considered for Tournament play. Players will need to provide all required paperwork by the deadline set out by the League. There will be no exceptions to the deadline, regardless of reason.

**Player & Parent Conduct:** Attitude will be a factor in deciding eligibility. Just because you are a "good player" doesn't necessarily warrant placement on a tournament team. A player should have an all-around team player attitude. Talking down or bad about umpires, managers and coaches, teammates or opponents will not be tolerated and will affect a player's eligibility for tournament team selection. Just as player attitude is important, parent conduct is as well. Arguing with umpires about calls made in a game, bad mouthing parents or players of the same team or opponents, posting negative remarks about the League and its volunteers to social media, will all have negative effects on your athlete being considered for selection. We want parents and players who will represent the League in a positive way rather than bring negative attention. Negative parent conduct throughout the regular season will have an adverse effect on player tournament selection and they will not be considered for selection.

**Commitment:** Practice and games are crucial to tournament play. If you have a planned vacation or surgery, plan to play on a summer club team or special tournament, and/or just cannot be committed to the practice schedule of Monday – Saturday during tournament season, you will not be considered for selection.

Tournament Managers will be selected by the President, Vice President and Division Director based on manager interest. Coaches will be considered for selection only when not enough managers have shown interest.

The selected tournament manager will be required to attend a District division tournament meeting, time and location TBD.

All managers in the division are required to attend the selection meeting and bring with them their season score book, season schedule and played games v. remaining games. If the manager cannot attend, a member of the team coaching staff may attend. A team without representation at the selection meeting will result in the players from the team to be ineligible for selection as we will not be able to confirm eligibility.

Selection of one player per Spring team is recommended but not required. Selection will be made by an overall incorporation of the above referenced criteria

A tournament team will be comprised of one (1) manager and two (2) coaches, along with 12 - 13 players. Though the Little League Rulebook allows for a tournament team to carry a minimum of 10 players, Coronado Little League will place no less than (12) twelve players, given there is enough players for selection.

## **BYLAW XXIII – LEAGUE PLAYER FEES & REFUND POLICIES**

## **SPRING SEASON:**

#### Tee-Ball Division: \$75.00 per player

Fees will cover ball cap, uniform shirt, team charter fee, player insurance and District player dues. No refunds will be permitted after February 16, 2025, no exceptions. A late fee of \$25 will be applied for anyone registered after February 15, 2025.

#### Slugger-Player Pitch Division and Above: \$130 per player

Fees will cover ball cap, uniform shirt, belt, team charter fee, player insurance and District player dues. No refunds will be permitted after February 16, 2025, no exceptions. A late fee of \$25 will be applied to anyone registered after February 15, 2025.

Refundable Fundraising Fee in all Division: \$50.00 per family

Players will participate in a league wide fundraiser. When turning in your fundraising forms and money, all families that have sold 10 or more items will be refunded their \$50 fundraising fee. Fundraising packets will be distributed during all (3) three mandatory player verifications.

## FALL SEASON: Fees for all players, regardless of division: \$80.00

Fees will cover ball cap, uniform shirt and box of team game balls. No refunds will be permitted after July 20, 2025. A late fee of \$25 will be applied for anyone registered after July 19, 2025.

**ALLSTAR TOURNAMENT SEASON:** <u>Fees for all players, regardless of division: \$120.00</u> Fees will cover ball cap, uniform shirt and pants, belt, socks and tournament charter fee. Refunds will not be permitted.

# **BYLAW XXIV – BOARD OF DIRECTOR PLAYER FEES**

**SPRING SEASON:** Members will not be required to pay spring season dues for up to two (2) players, with any additional player fees paid at half  $(\frac{1}{2})$  price, as an incentive to their volunteer efforts. Should a member not fulfill their volunteer duties or exit the board for any reason during the season, per player fees will be due in full, fourteen (14) days from the date of exit. Board members will be responsible for the League \$50 fundraising fee as outlined in Bylaw XXIII.

FALL SEASON: Fees will be paid in full as set for all members of the League during the Fall Season

**ALLSTAR TOURNAMENT SEASON:** Fees will be paid in full as set for all members of the League during the Allstar Tournament Season.

# BYLAW XXV – LEAGUE OFFERED DISCOUNTS

Discounts cannot be combined. One discount per family is permitted. Discounts cannot be carried over from season to season. Discounts do not apply to Fall Ball and/or Allstar Season.

## **BYLAW XXVI – DIVISION RULES**

#### **TEE-BALL DIVISION** – League Age 4 – 5. (League Age 6 with proper evaluation of skills)

Teams will be comprised of ten (10) to eleven (11) players to a team.

Game length shall be four (4) innings in length or  $1\frac{1}{2}$  hours, whichever comes first, no more, no less unless restricted by weather conditions or sunlight.

The Home team must prepare the field before each game, including raking, watering, chalking and setting up the bases. Home team should report to the field for set up  $(\frac{1}{2})$  half an hour before the official start of games. The Visiting team must repair the field after each game, including and locking up bases and tools.

No Score is to be kept.

Teams will follow continuous batting order each inning. The Inning will retire when the <u>entire</u> batting line-up has completed hitting.

Base runners shall not advance on an overthrow.

Three (3) defensive coaches will be allowed for guidance on the field. Defensive coaches should stay away from the play of the ball and stay clear of defensive players.

Four (4) offensive coaches will be allowed. Two (2) base coaches, one (1) coach for hitting and one (1) in the dugout is always required.

The ball must travel ten (10) feet to be a live ball.

The infield fly rule does not apply.

The position of catcher is prohibited. One (1) pitcher will be allowed. One (1) player per infield position and all remaining players are to be in the outfield.

Three (3) soft toss, kneeling, overhand pitches to a batter per plate appearance. The coach must be in front of the batter and approximately fifteen (15) feet away. If all three pitches are missed, then the ball will be placed on the tee. The players will be given 4 opportunities to get a hit off the tee and then should proceed to take a base.

Coaches that are providing a soft toss are prohibited to encounter the live ball. Please allow the defensive team to field the ball and make a play.

Each team is responsible for any and all trash in their respective dug outs and on their side of the bleacher area.

## SLUGGER CO-ED PLAYER PITCH DIVISION – League Age 6 – 8.

Teams will be comprised of 12 - 13 players to a team. The team is allowed one (1) manager and two (2) coaches. You must always have one (1) coach in the dugout, the other should be one of two base coaches with the Manager.

The Home team must prepare the field before each game, including raking, watering, chalking and setting up the bases. Home team should report to the field for set up  $(\frac{1}{2})$  half an hour before the official start of games. The Visiting team must repair the field after each game, including locking up bases and tools.

The Home team will provide the Plate Umpire, and the Visiting team will provide the Field Umpire. Umpires should report (½) half an hour before the official start of games. Disrespectful behavior in any manner to the umpires will not be tolerated and will lead to removal from the game and complex.

Teams play (6) six innings. There is a (2) two-hour time limit on all games unless restricted by weather conditions or sunlight. Umpires and Managers should maintain an active pace so that as many innings as possible are completed. The time in the dugout between innings should be limited to (2) two minutes.

Ten Run Rule: If after (4) four innings (or 3 innings if the home team is leading), a Team has scored 10 or more runs than its opponent, the game is over. This is not an option.

A team may not score over (5) five runs in any half inning during the first (4) four innings. Exception: If runners are on base and a home run clears the fence, all runners score. No run limit exists in the 6th inning.

Teams will follow a continuous batting order each inning. Each defensive team will have a maximum of nine (9) defensive players. There will be unlimited defensive substitutions.

Defensive players cannot play more than three (3) innings in the infield. Players cannot play a position more than once per game, except catcher. A defensive player cannot exceed two (2) innings at the catcher position consecutively, per game.

No bunting. The infield fly rule does not apply.

The batter that has batted the ball to the outfield can proceed only until a defensive player has possession of the ball infield.

No on-deck batter warm-ups are allowed.

Three (3) swinging strikes to the batter will be an out. A tip or foul ball will not constitute an out. If the batter fouls the  $6^{th}$  pitch, they will be awarded a  $7^{th}$  pitch. If the batter fouls the  $7^{th}$  pitch, an  $8^{th}$  and final pitch will be given. An out will not be registered if the batter fouls the  $8^{th}$  pitch. The next batter will be up.

Male players are required to wear a cup regardless of position played.

Teams will participate in an end-of season Round Robin tournament beginning in mid- May only if more than 3 (three) teams in the division.

TOURNAMENT: Games shall be four (4) innings in length. If after 4 complete innings the teams are tie, a complete five (5) innings will be played. The Championship Game will be played in a complete six (6) innings.

# MINOR BASEBALL & SOFTBALL DIVISION<sup>1,2</sup> - League Age 9 – 10

Teams will be comprised of 12 - 13 players to a team. The team is allowed one (1) manager and two (2) coaches. You must have one (1) coach in the dugout at all times, the other should be one of two base coaches with the Manager.

In the Minor Division, the Home team will provide the Plate Umpire, and the Visiting team will provide the Field Umpire. Umpires should report (½) half an hour before the official start of games. Disrespectful behavior in any manner to the umpires will not be tolerated and will lead to removal from the game and complex.

Teams play (6) six innings. There is a (2) two-hour time limit on all games unless restricted by weather conditions or sunlight. Umpires and Managers should maintain an active pace so that as many innings as possible are completed. The time in the dugout between innings should be limited to (2) two minutes.

Ten Run Rule: If after (4) four innings (or 3 innings if the home team is leading), a Team has scored 10 or more runs than its opponent, the game is over. This is not an option.

A team may not score over (5) five runs in any half inning during the first (4) four innings. Exception: If runners are on base and a home run clears the fence, all runners score.

No run limit exists in the 6th inning. Run Limits in this Division are usually imposed by Inter-League Rules.

Male players are required to wear a cup regardless of position played. It is recommended that female players wear a fielding mask. Female catchers are encouraged to consider the use of a pelvic cup, though is not required.
