Basketball Committee Meeting Notes 3/1/20

- Rename Players to NCAA & WNCAA and Premier to NBA & WNBA
- Travel evaluations/travels will be done via committee, not just coaches
 - o People will be named prior to tryouts
 - Head coaches of each team will have the final say
- New grade breakdowns moving forward
 - o K-1st
 - NCAA & WNCAA 2nd-3rd grade
 - o NBA & WNBA 4th-5th grade
 - o Patriot League 6th-8th grade (that did not make travel or middle school teams)
 - Games will take place at Red Mill or Red Land, Sunday evenings
- NCAA/WNCAA will have PIAA refs
 - Nick to gauge financial impact
- NCAA/WNCAA will keep scores on boards unless team is up by 15 or more
- NCAA games will take place during the week at Newberry
 - Nick to check with EpSports on impact to refs during weeknights
- WNCAA games will take place at RLHS prior to NBA/WNBA
- WNCAA NCAA/WNCAA practices will take place during the weekends @ Red Mill
 - Saturday 1 hour clinic with 30 min team break out
 - Sunday 1 or 1.5 hour team practices at Red Mill?
- All games moving to two 16 minute halves
 - Subs every four mins
 - o Running clock except last 60 seconds of each half
 - One 30 second time out per half, use it or lose it
 - Overtime one 30 second per (no transfer of unused time outs from 2nd half) ties (except playoff) end in a tie
- NCAA/WNCAA no foul shots
- NCAA BLOBs are ok
- WNCAA no BLOB, only SLOB or check at the top
- All divisions
 - If kids miss two practices without an excuse coach only needs to play 25% of the following game
 - Once practices are being attended again they resume to 50%
 - If any more practices are missed back to 25% and pattern continues for the season
 - Coach to contact the director if they are in a situation where the 25% rule is going to be applied
 - Teams will be assigned volunteer days to help with game days
 - Double elimination moving forward for Rec (February Frenzy)
 - Weekday games until Final Four
 - Final Four on weekend
- Outsource K-1 to Unleashed Potential again or Advanced Hoops in exchange for sponsorship?
- Winter travel tryouts remaining in September
- Rec evals remain in October
- 4th grade boys travel rejoin Advanced Hoops possibly
- 4/5th grade girls travel host on Saturdays
