I have read all the information below and have received my child's equipment. I assume responsibility for the reasonable care of uniforms and equipment issued to the player \_\_\_\_\_, and agrees to return those items at the end of the season. I understand that I will be billed and will be responsible for reimbursing the County for the replacement value of any item not returned. Missing Jerseys will result in only ½ a refund. I understand that all items issued including: Helmets, shoulder pads, game uniforms, and practice uniforms must be returned in good condition upon request, by the end of the season or by December 17, 2018. Game pants and game jerseys will be provide to each player during practice. A deposit check of \$300 will be required for all the above equipment. Checks are held until equipment and uniform is returned to the Hurricanes Recreation Supervisor, at the end of the season. Failure to return my players equipment at the turn-ins at end of the season will result in forfeiture of your equipment deposit. All equipment must be cleaned and uniforms washed (practice pants bleached-if white). If uniform is not clean, I will be charged \$15 or non-return of my check.

Please put child's name in the lower left corner of your check. Verify that we have a current phone number on the check. Replacement equipment that may be needed during the season should be purchased through your child's coach or the team's equipment director. Please do not place Game Jerseys in dryers, this causes the numbers to come off and you could be charged for it.

Players will be required to provide an athletic supporter, socks, cleats and any additional protective equipment they desire. Parents/Legal Guardians will be charged for the replacement value of any equipment items missing at equipment turn in.

\* If a check is returned for any reason a \$35 fee will be added and restitution must be made before your child can participant in another County program.
