

# Lady Mac Hoops

## Code of Conduct

**Players, their parents and/or guardians, and Coaches are all expected to obey the Policies and Procedures of the Lady Mac Hoops Organization. Each Player and at least one parent/guardian are required to sign this Code of Conduct and inform all other parents/guardians of the rules by which everyone must abide before the Player may participate in any activity condoned by Lady Mac Hoops.**

1. Participation in practice is mandatory. There is a league-wide rule that if a player misses all practices in the week (Monday - Sunday) prior to a game, they will not be permitted to play in the first half of the first game following the missed practices. If there are two or more practices that week and a player misses one, there will not be a playing penalty if the Coach is notified by using the "Availability" button on TeamSnap. This rule is in effect, regardless of the reason for missing practice.
2. Players should be on time for practice. That means arrive 10 minutes early to get shoes on, fill water bottles and use the restroom. A coach should be notified if a player is going to be late. If being late is an ongoing problem, this will be reflected in the athlete's playing time.
3. Profanity and derogatory comments will not be tolerated by players, coaches or parents/guardians. We encourage you to cheer for your athlete and her team members. Parents will not yell at the coaches or referees from the stands or anywhere in the gym. Any player using profanity or making derogatory comments will be suspended for two games. Detrimental conduct from players or parents/guardians will result in either suspension or dismissal from the team if considered serious enough by the coaches or board members of Lady Mac Hoops.
4. The ~~#####~~24-Hour Rule~~#####~~ will be strictly enforced. If you have an issue, you must wait 24-hours before contacting the appropriate Coach. If the issue is still unresolved, you may then contact a Board Member. This includes any complaints about coaching decisions during a game such as individual playing time. This concern may be addressed with the associated Head Coach with additional participation from an assistant coach or other appropriate team representative 24-hours after the conclusion of the game. Both parents/guardians and coaches have the right to request the participation of an assistant coach and/or team representative for any discussion. If the issue is not properly resolved a formal complaint may then be filed with the Board by the Team Representative.
5. Players are subject to the Canon-McMillan School District policies regarding tobacco, alcohol, drugs and controlled substances on school property and will be subjected to disciplinary actions and dismissal from the program.
6. Players must report all injuries and ailments to the coaching staff as soon as it happens.

7. Appropriate gym clothes are required for practices. No jewelry may be worn at practices, open gyms or games. This includes all body piercings.
8. Lady Mac Hoops provides each Player with one uniform during their first season. Players and parents/guardians are responsible for all Player uniforms. If any part of the uniform is damaged, lost, stolen or outgrown, a replacement must be purchased by the parents/guardians.
9. Parents/guardians are responsible for transportation of their children to and from games and practices.
10. At least one parent will participate in all fundraising events. (Fall Tournament and Spaghetti Dinner).

The Coaching Staff and Lady Mac Hoops Board of Directors will not tolerate ANY discipline problems. Any Player, who violates our Code of Conduct, on or off the court, in season or out of season, will be subjected to suspension or dismissal from the team. We will win or lose with respect and dignity before we sacrifice our principles. It is a privilege, not a right, to represent Canon-McMillan Lady Mac Hoops and the community. We believe basketball is an educational experience and we want the game and our team to be a positive influence in each player's life. Thank you for entrusting your daughters into our care and guidance.

I hereby understand and consent to abide by the Code of Conduct set forth above. I understand that these rules extend to parents/guardians in any Lady Mac Hoops related activities, including any leagues or tournaments. I understand that if I violate any of the Policies, I will be subject to whatever disciplinary action deemed appropriate by the authorized person or persons, Lady Mac Hoops Board of Directors member or committees of Lady Mac Hoops.
